Pavilion Rates **DO NOT INCLUDE FREE ENTRY** into the park for your guest. An entrance fee will be taken as usual from all persons entering the park. The pavilion will be inspected prior to releasing the unit for rental to your group or party, and its condition duly noted. By affixing your signature to this agreement, you thereby assume all responsibility for the area, clean-up, and protection of the pavilion and its contents, and agree to pay for any damage occurring during this period. Do not remove any picnic tables from pavilions.

Renter will also be responsible for a \$20.00 deposit to finalize this reservation. Rental Fee is due two weeks in advance of the date of event. Renter assumes all assumption of risk and will not hold Mobile County or Chickasabogue Park liable for any risk, actions or events that may occur during renter's contract agreement. Renter furthermore agrees to abide by all the rules and regulations governing the use of Mobile County's Chickasabogue Park.

NOTE: After deposit is paid and reservation is finalized, no part of the deposit is refundable. Cancellations result in loss of the deposit. A three weeks' notice of cancellation is required for any remaining portions of the RENTAL FEE to be refundable if paid in advance.

Chickasabogue Park further reserves the right, at any time during occupancy, if any of the above agreements are not met, to require the pavilion to be vacated.
