Residential Permits - One and Two Family Dwellings

Conditioned new construction and additions 25 plus \$0.62/square foot \$225. min.

Includes fee for building, electrical, mechanical, plumbing, roof and miscellaneous permits like ground rod, early service release, temporary pole, fireplace, and sidewalk. Applies to new construction and additions of air conditioned space.

Commercial Permits

All new construction and additions 0.6% of contract cost \$200 min.

Includes fee for all work that is included in the contract cost.

Includes 0.1% Construction Industry Craft Training Program enacted by the Alabama State Legislature as Act 2015-308 and signed by the Governor on June 3, 2015

Plan Review \$100

Building, electrical, plumbing or mechanical repairs, renovations or other alterations

Work Without Permit or during Stop Work Order

*Offenses are cumulative through December 31st each calendar year

Re-Permitting

A building permit is valid for a maximum of one year from the issue date. At the discretion of the Building Official, a valid permit may be re-permitted for up to one year from the original expiration date as follows:

| <u>Duration</u> | <u>Fee (%of original fee)</u> |
|-----------------|-------------------------------|
| 10 days | 5% |
| 30 days | 10% |
| 60 days | 15% |
| 180 days | 30% |
| One year | 50% |

Re-permitting shall be preceded by an on-site Investigation (see fee schedule). The investigation may be waived by the Building Official if all inspections prior to finals have been passed. Re-permitting is subject to building codes effective on the date of re-permitting.

Cancellation/ Refunds

Permit fees will not be refunded after any inspections have been performed.
Permit fees will not be refunded after one year from the permit issue date.
Permit fees will only be refunded to the permit holder.
Building permits are subject to a \$100 cancelation fee.

Valuation for permitting shall not be less than the following:
