Established:

Mobile County Commission authorized the operation of the Senior Companion Program of Mobile County Advisory Council at its regular meeting on October 14, 1980.

The Senior Companion Program of Mobile County Advisory Council is an initiative of the Corporation for National and Community Services (CNCS).

The Mobile County Commission sponsors the Senior Companion Program of Mobile County Advisory Council.

Purpose:

The purpose of the Advisory Council is to assist and advise the Senior Companion Program sponsor and staff on matters concerning planning, community support, project policies, and operational issues; and participate in the evaluation of the program's effectiveness in meeting performance measures provided for in the approved grant application.

Membership:

The Membership Committee will recommend potential names for membership to the Advisory Council that will be approved by the Advisory Council and referred to the Program Director for consideration by the sponsor, the Mobile County Commission.

The Advisory Council shall be composed of a minimum of twelve (12) members but not more than eighteen (18) members who represent the population of the area served and the senior volunteers. One-fourth (1/4) of the membership must be fifty-five (55) or older, some of these shall be volunteers in the Senior Companion Program.

Appointments:

The Mobile County Commission appoints the members.

Term:

One (1) year, Two (2) years, and three (3) years.
