Public Hearing - Amendments PY2021, PY2022 and PY2023 Action Plans

The purpose of this notice is to solicit citizens' comments and to give notice of a public hearing regarding the proposed amendments to the Mobile County Urban County PY2021, PY2022 and PY2023 Action Plans. The Public Hearing will be held prior to final adoption by the Mobile County Commission at the regular County Commission meeting to be held at 10:00 a.m. on December 21, 2023, in the auditorium, located on the ground floor of the Mobile Government Plaza, at 205 Government Street in Mobile, Alabama.

**Proposed amendments:**

1. Reallocate CDBG funds of \$50,000 (PY2021) and \$150,000 (PY2022) for a total of \$200,000 from the project Hurst Street Improvement, Creola, and \$300,000 (PY2023) from the Rehabilitation of Bridges on Warren Street and Wasson Avenue, Prichard to the Mausap Road Improvements project.

A complete and detailed copy of the proposed amendment will remain on file at the offices of the Mobile County Commission and will be available for public examination and copying upon request at the Mobile County Government Plaza, 205 Government Street, Mobile, Alabama between the hours of 9:00 a.m. and 4:00 p.m. Monday through Friday, excluding holidays. The proposed amendment is also available on the County web page, [mobilecountyal.gov/grants/public-notificationshearings/](http://mobilecountyal.gov/grants/public-notificationshearings/) under Grants Department.

A 30-day public comment will commence beginning November 15, 2023 until December 21, 2023. Written comments are to be sent to Director of Grants Management, Mobile County Commission, 205 Government Street, Mobile, AL 36644.
