CDBG Amendments PY2019, PY2021, PY2022, PY2023 and PY2024 Action Plans  
HOME Amendments PY2021 and PY2024 Action Plans  
CDBG-CV Amendments PY2020 Action Plan

The purpose of this notice is to solicit citizens' comments regarding the amendments to the Mobile County Urban County PY2019, PY2020, PY2021, PY2022, PY2023 and PY2024 Action Plans.

**Amendments:**

**CDBG**

1. Reallocate CDBG funds of \$33,388.79 (PY2019) from County Spot Blight Clearance to Bayou La Batre Senior Center Improvements (HVAC System).
2. Reallocate CDBG funds of \$4,216.64 (PY2021) from Prichard Spot Blight Clearance to Creola Street Improvements Hurst Street.
3. Reallocate CDBG funds of \$753.50 (PY2022) from CDBG General Administration to Creola Street Improvements Hurst Street.
4. Reallocate CDBG funds of \$200,000 (PY2022) from the Wilmer Senior Center Acquisition and Construction project to the Semmes Senior Center Walking Trail project.
5. Reallocate CDBG funds of \$905.15 (PY2023) from City of Semmes Senior Services, \$0.01 from Legal Services Alabama Homelessness Prevention, \$8.72 from Grand Bay SARPC-Meals for Seniors and \$9,371.83 from Boys & Girls Clubs–Summer Youth Program to Creola Street Improvements Hurst Street.
6. Reallocate CDBG funds of \$247,507 (PY2023) from the Wilmer Senior Center Acquisition and Construction project to the Semmes Senior Center Walking Trail project.
7. Reallocate CDBG funds of \$33,388.79 (PY2024) from Bayou La Batre Senior Center Improvements (HVAC System) to County Spot Blight Clearance (\$20,000.00) and Creola Street Improvements Hurst Street (\$13,388.79).

**HOME**

1. Reallocate HOME funds of \$250,000 (PY2021) from the Rental Housing - Acquisition/Development/Construction project to the Down Payment Assistance (DPA) Program.
2. Reallocate HOME funds of \$100,000 (PY2024) from the Single-Family Affordable Housing - Acquisition/Development/Construction project to the Rental Housing Program - Acquisition/Development/Construction project.
3. Reallocate HOME funds of \$100,000 (PY2024) from the Single-Family Affordable Housing - Acquisition/Development/Construction project to the Down Payment Assistance (DPA) Program.

**CDBG-CV**

1. Reallocate CDBG-CV funds of \$19.66 (PY2020) from Food Banks, \$167,069.90 from Legal Services/Mortgage/Rental Assistance, \$107,355.58 from Child Care Services, and \$11,017.84 from Semmes Senior Center Improvements for a total of \$285,462.98 to Fire Equipment.
2. Reallocate CDBG-CV funds of \$264,167 (PY2020) from Fire Equipment and \$135,833 from Administration for a total of \$400,000 to Mobile Health Access – Equipment Purchase.
