**REQUEST FOR RELEASE OF FUNDS**

On or about May 12, 2025 the Mobile County Commission will submit a request to the U.S. Department of Housing and Urban Development for the release of Community Development Block Grant (CDBG) funds authorized under Title 1 of the Housing and Community Development Act of 1974, to undertake a project known as Homeowner Emr Roof Replacement 3000 Schillinger Rd N for the purpose of replacing the roof on a existing single family home located at 3300 Schillinger Rd N Semmes, AL 36575. The estimated funding amount for this program is \$15,000.

**FINDING OF NO SIGNIFICANT IMPACT**

The Mobile County Commission has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at 205 Government Street, 8<sup>th</sup> Floor, South Tower, Mobile, AL 36644 and may be examined or copied weekdays 8 A.M to 5 P.M.

**PUBLIC COMMENTS**

Any individual, group, or agency may submit written comments on the ERR to the Mobile County Grants Department, 205 Government Street, 8<sup>th</sup> Floor, South Tower, Mobile, AL 36644. All comments received by May 11, 2025 will be considered by the Mobile County Commission prior to authorizing submission of a request for release of funds. Comments should specify which Notice they are addressing.

**ENVIRONMENTAL CERTIFICATION**

The Mobile County Commission certifies to the U. S. Department of Housing and Urban Development that Merceria Ludgood in her capacity as President of the Mobile County Commission consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the Mobile County Commission to use Program funds.

## **OBJECTIONS TO RELEASE OF FUNDS**

HUD will accept objections to its release of funds and the Mobile County Commission's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the Mobile County Commission; (b) the Mobile County Commission has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to U. S. Department of Housing and Urban Development, CPD Division, 417 20<sup>th</sup> Street North, Suite 700, Birmingham, Alabama 35203 and submitted to [CPDRROFBHM@hud.gov](mailto:CPDRROFBHM@hud.gov). Potential objectors should contact HUD via email to verify the actual last day of the objection period.
